

## COMMISSIONERS PROCEEDINGS, APRIL 4th, 1933.

The Board of County Commissioners met this 4th day of April, A. D. 1933, with all members present, Frank Schilt presiding.

A committee consisting of Anthony Stratton, Ralph Campbell and Fred Healey, in behalf of Carbon County Tax Payer's League, met with the Honorable Board to discuss defraying County expenses and to eliminate all such unnecessary deputies or other help, whereupon the Board agreed to take this matter under consideration.

The balance of the day was taken up with delegations from every section of the County, with petitions bearing names of the largest taxpayers urging the Honorable Board to reinstate the Deputy Sheriffs, I. R. Daugherty, R. E. Cooper, Evan Jones and R. E. Baldwin. Upon motion of D. C. Kinnaman, seconded by Glen Penland and duly carried, the re-appointments of said Deputy Sheriffs were confirmed and ratified.

The Board recessed to meet the following day.
