The Board of County Commissioners of Carbon County, Wyoming, met at 11:25 A. M., July 23, 1934, convened as the County Board of Equalization of said County, pursuant to CERTIFICATE AND ORDER of the State Board of Equalization of Wyoming, dated July 16, 1934, copy of which is hereto attached and marked "EXHIBIT A" and by reference made a part hereof.

In accordance with said Certificate and Order, the Mineral Reservation Lands was increased as twenty-five cents (25¢) per acre, which changed this item on the Abstract of Assessment Roll from \$151,511.00 to \$242,491.00 making the corrected net total of the County valuation \$12,644.932.00

WHEREFORE IT IS HEREBY ORDERED, that the County Assessor of Carbon County, Wyoming, furnish the State Board of Equalization of Wyoming, with a corrected Abstract not later than the 30th day of July, 1934.

No further business coming before the Board, upon motion of Glenn Penland, seconded by D. C. Kinnaman, the meeting adjourned.

STATE BOARD OF EQUALIZATION

IN THE MATTER OF VALUATION OF PROPERTY
FOR TAXATION PURPOSES FOR THE YEAR 1934

CERTIFICATE AND ORDER

TO THE BOARD OF COUNTY COMMISSIONERS
OF CARBON COUNTY, STATE OF WYOMING.

GREETING:

Upon careful examination and analysis by this, the State Board of Equalization of the State of Wyoming, of the Abstract of Assessment Roll of Carbon County, State of Wyoming, for the year 1934, filed with this Board by the Assessor of said County on the 29th day of June, 1934, it appears by said abstract and the records, and the State Board of Equalization so finds, that for equalization purposes, the evident undervaluation of Mineral Reservation Lands to such an average amount per acre as to result in unequal and un-uniform valuation, as compared with the same classes of lands in other counties in the State, must be corrected.

WHEREFORE IT IS HEREBY ORDERED, that you, the Board of County Commissioners of said County, convene as the County Board of Equalization of said County, not later than the 24th day of July, 1934, and take such action as may be necessary to require the Assessor of said County to increase to twenty-five cents (25¢) per acre the valuation of Mineral Reservation Lands in said County for the purpose of establishing the proper average value of said lands on an equitable basis for such lands throughout the State:

AND IT IS FURTHER ORDERED THAT you instruct the County Assessor to furnish this Board with a corrected abstract not later than the 30th day of July, 1934.
