

SPECIAL MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY.

Pursuant to the provisions of law, the Board of County Commissioners, met this 5th day of August, 1935 to fix the tax levies for and within the County of Carbon, for the year 1935. There being present Gus Larson, Chairman, Frank Schilt and Eugene McCarthy, the other two members of the Board and Linda A. Felton Clerk.

Having received from the State Board of Equalization notice that the assessed valuation of Carbon County for the year 1935 had been found to be \$21,871,163.00 and that the State tax levy applicable to all assessed property within the State had been fixed at two (2) mills; and that the County Assessor had advised the Board of the assessed valuation of each of the various municipalities and school districts within the County, the Board proceeded to fix the levies upon the assessed property of Carbon County for the year 1935 as follows:
