Said delegation was advised by the Board that a road to the Cemetery would be constructed as soon as conditions would allow and the matter pertaining to the road from Lincoln Highway into Hanna would be discussed at once with the State Highway Commission.

as Medicine Bow-McCreaden road commencing at a point in the ~~beginning~~ or section 8, T. 22 N., R. 78 W., which is located N. 21° 15' W. 3401 feet from a point which is located N. 83° 19' E. 972 feet from the south quarter-corner of said Section 8; running thence in a general southerly and southeasterly direction through Sections 8, 17, 20, 29, 32 and 33, T. 22 N., R. 78 W.; Sections 4, 3, 10, 9, 16, 21, 22, 27 and 34, T. 21 N., R. 78 W.; Sections 4, 9, 16, 15, 22, 23, 26 and 27, T. 20 N., R. 78 W.; terminating at a point on the south line of Section 27, T. 20 N., R. 78 W., located east 463 feet from the south quarter-corner of said Section 27, and a list having been filed on the same date with said petition purporting to contain the names and known Post Office addresses of each person owning or interested in the land across which the establishment of said proposed road is requested, was brought up at this time for consideration, and after due consideration thereof it was moved by Eugene McCarthy and seconded by Frank Schilt that C. R. Watson be appointed viewer of the proposed road and to report immediately as by law required.

Viewers' Report

The report of C. R. Watson, having been duly filed on April 8th, A. D. 1936, the Viewer appointed to view the proposed Medicine Bow-McFadden road, was brought up at this time and after due consideration being given same it was moved by Frank Schilt, seconded by Gus Larson, that said proposed Medicine Bow-McFadden road be laid out and established as in the petition therefore requested. Motion regularly adopted.

It was regularly moved by Frank Schilt seconded by Eugene McCarthy that Friday, May 8th, 1936 be set as the day at noon thereof, on or before which day all objections to the establishment of the proposed Medicine Bow-McFadden road and claims for damages therefore should be filed with the County Clerk of Carbon County, Wyoming, and that due notice thereof as required by law, shall be given publication in the Rawlins Republican, for three successive weeks. Said motion adopted.

It was then regularly moved by Frank Schilt and seconded by Gus Larson which motion was adopted, that the County Clerk send by registered mail, with return receipts requested, a copy of the published notice to all persons of record, owning lands or claiming any interest in any lands traversed by said proposed Medicine Bow-McFadden road.

Upon motion meeting was adjourned until the following/at 10:00 o'clock A. M.

The Board resumed its session this 9th day of April, A. D. 1936, at 10:00 o'clock A. M., with all members present.
