SATURDAY, JULY 11, A. D., 1936.

The Board of County Commissioners of the County of Carbon, State of Wyoming, met this day, to-wit, the 11th day of July, A. D., 1936, at the hour of 2:30 o'clock P. M., in special session, to consider the advisability of building an addition to the Carbon County Memorial Hospital at Rawlins, and issuing bonds to finance the same, and to issue a proclamation relative to a special election to be held on the 18th day of August, A. D., 1936, and for the consideration of such other business that might properly come before the meeting in connection therewith. Present: Chairman, Gus Larson; Commissioners, Frank Schilt and Eugene McCarthy.

Eugene McCarthy offered the following resolution:

"WHEREAS, the present Carbon County Memorial Hospital building is now inadequate to furnish accommodations to the inhabitants of Carbon County, Wyoming, and

WHEREAS, it is believed that it is necessary to construct an addition thereto and that the best interests of Carbon County, Wyoming, and its inhabitants would be served thereby, and

WHEREAS, bonds of said county should be issued and sold for the erection, construction and completion of an addition to said hospital, and

WHEREAS, said bonds, together with all other outstanding indebtedness of said Carbon County, Wyoming, will not exceed the limitations imposed by the Constitution and Statutes of Wyoming at two (2%) per cent of the assessed valuation of the taxable property within said county as shown by the last preceding general assessment.

NOW THEREFORE, BE IT RESOLVED AND ORDERED, by The Board of the County Commissioners of the County of Carbon:

1. That a special election of the qualified electors of Carbon County, Wyoming, is hereby called and ordered to be held on Tuesday, the 18th day of August, 1936, on which date, during the times and at the places in this resolution designated, the question of the issuance and sale of bonds of said county in a sum not exceeding Thirty Thousand (\$30,000.00) Dollars, and bearing interest at a rate not exceeding four (4%) per cent per annum payable semi-annually for the erection, construction and completion of an addition to the Carbon County Memorial Hospital, shall be submitted to such qualified electors.

2. That the following Proclamation issue, the same to be posted in a conspicuous place in each post office within Carbon County, Wyoming, at least twenty (20) days prior to August 18, 1936, and to be published July 15, 1936, July 22, 1936, July 29, 1936, August 5, 1936, and August 12, 1936, in the regular edition of the Republican-Bulletin, the heretofore and now designated official newspaper of Carbon County, Wyoming, published in Rawlins, Wyoming, the same/ also to be posted and published in any other manner required by law.

PROCLAMATION FOR SPECIAL ELECTION.

Notice is hereby given that pursuant to law The Board of County Commissioners of the County of Carbon do hereby order and proclaim that a special election will be held in the several polling precincts in the various election districts within Carbon County, Wyoming, as designated herein, on the 18th day of August, 1936, for the purpose of submitting to the qualified electors of Carbon County, Wyoming, the following question:

"Shall the The Board of County Commissioners of the County of Carbon, State of Wyoming, be authorized and empowered to issue and sell the negotiable, general obligation coupon bonds of the County in a sum not exceeding Thirty Thousand (\$30,000.00) Dollars, bearing interest at a rate not exceeding four (4%) per centum per annum, payable semi-annually, for the purpose of providing funds for the erection, construction and completion of an addition to the Carbon County Memorial Hospital located at Rawlins, Wyoming. Said bonds to be payable at the option of said County ten

(10) years after date and absolutely due and payable twenty (20) years after date?"

At said election there shall be provided two ballot boxes for each polling precinct officially designated, one to be designated "Ballot Box A" and the other "Ballot Box B", and there shall also be provided at each polling place two sets of ballots, one of which shall be printed on white paper and the other on colored paper, both containing the same statement of the proposal to be voted upon and the same instructions respecting the manner of marking the ballots.

Every person who shall make an affidavit before a judge of such election to the effect that he is a citizen of the United States, of the age of twenty-one years and upwards, that he has resided in the State of Wyoming one year and in Carbon County for sixty days next preceding such election, shall be permitted to vote at said election.

If such an elector is not the owner of or the spouse of the owner of real or personal property assessed on the last preceding assessment roll of Carbon County, Wyoming, he shall be furnished by the officers conducting such election a ballot printed on white paper, and the ballots of all such persons shall be deposited in Ballot Box A.

If such elector is the owner of or the spouse of the owner of real or personal property assessed on the last preceding assessment roll of Carbon County, Wyoming, he shall be furnished by the officers conducting such election a ballot printed on colored paper, and the ballots of all such persons shall be deposited in Ballot Box B.

Before an elector shall be permitted to vote a ballot printed on colored paper he shall be required to make before the officers of election, who are hereby authorized to take the same, an affidavit showing that he is the owner of or the spouse of the owner of real or personal property assessed on the last preceding assessment roll of said Carbon County, Wyoming.

The judges and clerks, and/or those serving as such at such election, the polling places, polling precincts and election districts for the purpose of this election shall be the same as those designated by the The Board of County Commissioners of the County of Carbon for the holding of the primary election also to be held on August 18, 1936.

The polls shall open at nine o'clock A. M. of said day and remain open continuously until seven o'clock P. M. of said day, at which time they shall close.

Shall the The Board of County Commissioners of the County of Carbon, State of Wyoming, be authorized and empowered to issue and sell the negotiable, general obligation coupon bonds of the County in a sum not exceeding Thirty Thousand (\$30,000.00) Dollars, bearing interest at a rate not exceeding four (4%) per centum per annum, payable semi-annually, for the purpose of providing funds for the erection, construction and completion of an addition to the Carbon County Memorial Hospital located at Rawlins, Wyoming. Said bonds to be payable at the option of said County ten (10) years after date and absolutely due and payable twenty (20) years after date?"

Seconded by Eugene McCarthy, Motion unanimously carried.

It was moved by Frank Schilt and seconded by Eugene McCarthy that the County Clerk prepare all necessary notices, affidavits and ballots to be used in connection with said proposed bond election and to furnish all necessary supplies and to post and publish all notices required by law. Motion unanimously carried.

The meeting was then regularly adjourned.
