The undersigned, constituting a quorum of the Board of County Commissioners of Carbon County, Wyoming, beg to acknowledge receipt of a copy of the report of examination submitted to you by Examiners from your office at the close of business December 11, 1936 and pursuant to law, transmitted in due course for your information and consideration.

We have carefully considered this report and concur with the Examiner in his suggestions, and have requested the officials to make the necessary corrections in compliance therewith, to-wit:  
The Automobile Account, being kept by Mr. Friend, will be supervised by County Treasurer. The County Officials have been notified to remit all fees promptly each month to the County Treasurer, and all discrepancies found at the time of examination, as shown on the Examiners' Report, have been adjusted satisfactorily to the Board. The Commissioners will endeavor to see that the various officers carry out the Examiners' recommendations.

It is the aim of the Board to conduct the business affairs of the County as economically as possible, to encourage the different departments to keep within their budget and make every effort to get the County on a cash basis.
