"JUSTICE PRECINCT NO. 1-B"

Justice Precinct No. 1-B shall consist of all that territory in Election Districts Numbers 1 and 3.

Moved, seconded and carried that J. J. Hickey be and he is hereby appointed Justice of the Peace to fill the vacancy in Justice of the Peace Precinct No. 1-B as established at this meeting.
