R E S O L U T I O N

" WHEREAS it has been made to appear to this Board, upon evidence adduced and upon inquiry made, that the public interest requires the establishment of a highway 9.314 miles in length to further connect the highways of Carbon County with the present forest service road over Medicine Bow Range; said road beginning at a point in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 12, T. 16 N., R. 82 W. located S.27°04' W.1086.2 feet from the East quarter-corner of Section 12 T. 16 N., R. 82 W.; running thence in a general westerly direction through sections 12, 13, 14, 15, 16, 17, 20 and 19, T. 16 N., R. 82 W., and sections 24, 23, 22 and 15, T. 16 N., R. 83 W.; terminating at a point located S. 48°38' W. 852.5 feet from a point located S. 58°10' E. 1450.0 feet from a point on the west line of section 15, T. 16 N., R. 83 W., located south 23.6 feet from the west quarter-corner of said section 15; now, therefore,

BE IT RESOLVED that said road or highway 9.314 miles in length, beginning and terminating as aforesaid, and running through the Sections in the Townships and Ranges aforesaid, shall be established, and that proceedings in the establishment thereof shall be had as required by law, to be known as Saratoga-Centennial Road.

In compliance with Chapter 52, Wyoming Revised Statutes 1931, the said road notice was advertised and all the land owners being affected by the location of the said Saratoga-Centennial road, were duly notified by registered mail.
