

SPECIAL MEETING

Road

The Board of County Commissioners met this 10th day of January, A. D. 1938, in special session, for the purpose of selecting three appraisers to view that portion of the right-of-way of the Riverside-State Line road to be altered and widened and the following resolution was offered by F. F. Hansen:

WHEREAS, certain claims for damages have been made and filed against the proposed change of the said Riverside-State Line road,

NOW, THEREFORE, BE IT RESOLVED, that Frank Schilt, C. R. Watson and Wm. A. McKay, three disinterested electors of Carbon County, Wyoming be and they are hereby appointed appraisers to view the proposed change of that certain portion of the Riverside-State Line Highway, they to affix the amount of damages sustained by said claimants and to perform such other duties provided in Section 52-221 Wyoming Compiled Statutes 1931

Thereupon meeting was regularly adjourned until 10:00 o'clock A. M. the following day.

The Board resumed its session this 11th day of January, A. D. 1938, for the purpose of meeting with members of the Wyoming Stock Growers Association to discuss classification and valuation for the assessment of livestock for the year 1938.

Gus Larson presented and moved the adoption of the following resolution, whereupon said motion was unanimously carried and said resolution adopted to-wit:

RESOLUTION

WHEREAS the State Board of Equalization has certified to the several counties its classification and valuation for the assessment of livestock for the year 1938, which valuation contains substantial increases over the classification and valuation established by said Board for the year 1937, and

WHEREAS many protests have been received and considered by the Board County Commissioners of Carbon County against such increased valuations, and

WHEREAS it appears to said Board of County Commissioners that the present deplorable conditions existing in the livestock industry with the prevailing low market and increased costs of operation, are of such nature that the livestock valuations should be decreased rather than increased for the year 1938, and it further appears that an increase in such valuations is virtually confiscatory and highly prejudicial to the basic industry of the State, now, therefore,

BE IT RESOLVED, that the Board of County Commissioners of Carbon County does respectfully protest to the State Board of Equalization against the established increases in livestock valuations for the year 1938; and does respectfully urge said State Board to reconsider its established valuations for livestock and to establish the Valuations for the year 1936.

BE IT FURTHER RESOLVED that a copy of this resolution be forthwith furnished to said State Board of Equalization, and to all other interested parties, including the Board of County Commissioners of each County in the State of Wyoming.

No further business appearing meeting was regularly adjourned until Tuesday,

February, 1st, 1938.
