On motion of the Board made and carried Mark Heward was allowed a rebate of taxes for \$6.00 and Frank C. Cogdill an abatement for \$24.45.

By resolution of the Board made and carried the Chairman and Clerk were authorized to execute and deliver a Commissioners' Deed to Charles B. McDowell of Encampment, Wyoming.

Commissioner F. F. Hansen introduced the following resolution and moved its adoption. Said motion was seconded and unanimously carried.

R E S O L U T I O N

WHEREAS: The State Highway Department has decided to increase the width of the right-of-way of a portion of the Riverside-State Line road to a width of 200 feet;

AND WHEREAS, it appears to the Board that this alteration and increase in width is necessary for the proper construction and maintenance of this road;

NOW, THEREFORE, BE IT RESOLVED: That the Board of County Commissioners of Carbon County, Wyoming hereby establish and alter the Riverside-State Line road and declare said road established with a width of 200 feet through the following land:

Commencing at a point which is in Section 8, T. 13 N. R., 81 W. of the 6th P. M., Wyoming, which is 1101.7' S. 49° 25' E. of a point which is 2614.4' S. 38° 41' E. of a point from which the NE Corner of Section 7, T. 13 N., R. 81 W.

of the 6th P. M., Wyoming, bears N. $0^{\circ}37'$ E. a distance of 1262.2'; thence in a southeasterly direction through Sections 8, 17, 16, 15, 22, 23, 26, 25 and 36, T. 13 N. R. 81 W., of the 6th P. M., Wyoming; through Section 31, T. 13 N., R. 80 W., of the 6th P. M., Wyoming; and through Sections 6, 7, 8, 17 and 20, T. 12 N., R. 80 W., of the 6th P. M., Wyoming; to a point on the State Line common to the State of Wyoming and the State of Colorado, from which the Mile Post No. 124 on the State Line bears N. $88^{\circ}46'$ W., a distance of 3729.6'.

R E S O L U T I O N.

* WHEREAS, the Board of County Commissioners of Carbon County have established a portion of the Riverside-State Line road with a right-of-way width of 200 feet commencing at a point in Section 8, Township 13 North Range 81 West to a point on the Wyoming-Colorado line;

AND, WHEREAS, The State Highway Department is desirous of securing a right-of-way for said road as soon as possible so that contracts for the construction therefor can be let;

WHEREFORE, BE IT RESOLVED: That the Board of County Commissioners of Carbon County, Wyoming hereby guarantee to the State Highway Department that they will secure the desired right-of-way. *

The foregoing resolution was duly presented and read by Commissioner Fred Hansen, who thereupon moved its adoption, which motion was duly seconded and unanimously carried.

By resolution of the Board made and carried, S. S. Sharp was appointed Viewer, to view and report upon the widening of that certain portion of the Riverside-State Line road and that notice be given of the alteration and widening of said right-of-way, in compliance with Chapter 52, Wyoming Revised Statutes 1931.

There being no further business to come before the Board at this time, on motion, meeting was regularly adjourned until Tuesday, March 1st, 1938.
