

COMMISSIONERS' PROCEEDINGS.

The Board of County Commissioners met this 4th day of April, 1939 all members present, Fred F. Hansen presiding.

By unanimous action of the Board, E. E. Le Vasseur was appointed Water Commissioner for District 4 & 9 with approval of S. S. Sharp, Superintendent Water District No. 1.

Application of Richard Sharp was presented by water users of Platte Valley. The Board recommended that no new appointment be made in District No. 6, but that above applicant be used as deputy whenever in the opinion of the water Superintendent such employment is necessary in the regulation of this district.

Delegation representing the Rawlins Chamber of Commerce met with the Board to reconsider plans for holding the annual County Fair. On action taken by the Board the sum of \$1000.00 was appropriated for 1939 fair.

Thereupon the Board adjourned, to meet April 5th, 1939 at 10:00 o'clock A. M.

The Board met this 5th day of April, 1939, all members present, Fred F. Hansen presiding.

Motion was made by Commissioner Gooldy, seconded by Commissioner McCarthy, that applications of the following banks be approved as County depositories. First National Bank and Rawlins National Bank of Rawlins, Saratoga State Bank of Saratoga, Hanna State & Savings Bank of Hanna and the Medicine Bow State Bank of Medicine Bow.

On unanimous action of the Board, resolution was adopted authorizing the County Assessor to proceed with the collection of Poll Tax for the year 1939.

Delegation from Saratoga met with the Board to again discuss status of Saratoga-Centennial Highway and possibility of clearing protests filed, relative to same. The Board of County Commissioners increased the damages allowed by the Appraisers for the condemnation of a right of way for the Saratoga-Centennial road. E.J.Uihlein and Mrs. K. Enberg, and by resolution settled the claims of Wintrop C. Condict and Aurilla P. Condict, and authorized the Chairman and County Clerk to enter into an agreement with said parties as to time and manner of payment. The following resolution was introduced by Commissioner Gooldy, " BE IT RESOLVED, that the Board of County Commissioners of the County of Carbon, State of Wyoming, hereby settle the claims of Winthrop C. Condict and Aurilla P. Condict, his wife, in connection with the condemnation of a right of way for the Saratoga-Centennial Road across their lands for the additional sum of \$3000.00 and that the Chairman of the Board of County Commissioners and the Clerk thereof be authorized to enter into an agreement with the said parties as to the time and manner of payment." seconded by Commissioner McCarthy and unanimously adopted."

Additional bond for \$500.00 for C. R. Patterson, Justice of Peace at Baggs, Wyoming was approved and placed on file together with bonds of John S. Evans, Justice of Peace at Elk Mountain, and Robert R. Molyneaux Justice of the Peace at Hanna, Wyoming
