RESOLUTION AUTHORIZING CONTRACT CHANGES FOR CARBON COUNTY

COURTHOUSE, RAWLINS, WYOMING.

BE IT RESOLVED by the Board of County Commissioners of the County of Carbon, State of Wyoming, as follows:

1. That it is deemed advisable and for the best interest of said County that the contract between the said County and the Spiegelberg Lumber and Building Company, Contractors, covering work on the Carbon County Courthouse and Jail Building Project of said County, be changed in the following respects:

(a) Extra concrete pedestals be installed over north wall of north area to a total of 3.2 cubic yards of concrete. (\$29.44)

(b) Lavatory and water closet be roughed in in Room No. 27, but the installation of plumbing fixtures and floor drain in tunnel west of Pump Room No. 18 be omitted. (Deduct \$42.20).

(c) A new door be installed where directed, with steel jambs, communicating door lock and latch bolt, like type "I" door in partition between Treasurer's Office No. 131 and Assessor's office No. 133. (\$90.16)

(d) Glass screen between lobby No. 204 and corridor No. 227 be moved, door between Judges' Room No. 201 and Clerk of Court's Room No. 203 be moved southward, and book-shelves in Judges' Room be moved northward, all as shown on attached drawing. (No additional charge).

(e) Three 1/4" electrical conduits be installed from basement shop No. 16 to private offices Nos. 122 and 217, and to a position in utility corridor north of sleeping compartments on third floor. (\$110.00).

(f) East wall of Storage Room No. 5 be moved eastward, south wall of Storage Room be extended to a meeting point with new location of east wall, and soil pipe be encased, in accordance with attached drawing. (\$35.00)

2. That it is hereby determined that all the data necessary to obtain a comprehensive and intelligent bid, which data, prepared and assembled by Frederic Hutchinson Porter, are referred to herein and made a part hereof, were properly submitted to said Contractor with a request that such Contractor submit a proposal to said County covering/proposed changes,

3. That the proposal of said Contractor, a copy of which is hereto attached, and made a part hereof, to make the said changes, and accept therefor an increase in the contract price of Two Hundred Twenty-two Dollars and Forty Cents (\$222.40) be and the same is hereby accepted for and in behalf of said County.

4. That such acceptance of the Contractor's proposal shall become effective only when a certified copy of this resolution is sent to the Contractor by the Architect.
