

COMMISSIONERS' PROCEEDINGS.

The Board of County Commissioners met this 3rd day of October A. D. 1939, at 10:00 o'clock A. M. all members present, Fred F. Hansen presiding.

The School District Boundary Board, consisting of the Board of Commissioners, Miss Helen A. Irving County Superintendent of Schools, and Mrs. Mina T. Woodhouse, County Treasurer, read the request of Aden and Aden, that they be transferred from School District No. 26 to School District No. 9. Upon motion by McCarthy, seconded by Gooldy this request was unanimously approved.

The monthly reports of County officers were audited and approved and placed on file together with report of V. E. Farmer, secretary of Carbon County Fair.

On motion by McCarthy, seconded by Gooldy and unanimously carried, R. G. Engstrom was designated as Budget officer in compliance with 1939 Session Laws of the State of Wyoming, Chapter 87, Section 5.

The Spiegelberg Lumber and Building Company, contractors on Carbon County Court House & Jail, requested that extension of time be granted for completion of Contract No. 2. Upon motion by McCarthy, seconded by Gooldy, the following resolution was adopted by unanimous vote of the Board.

RESOLUTION EXTENDING THE TIME FOR COMPLETING THE GENERAL CONTRACT ON PROJECT WYO- 1083-F. CONTRACT No.2.

WHEREAS, Carbon County (Hereinafter referred to as "Owner") and Spiegelberg Lumber & Building Co. (Hereinafter referred to as "Contractor") have entered into a contract for the performance of certain work, in connection with the construction of certain Project of the Owner;

WHEREAS, it has been determined for the reasons hereinafter enumerated, it has become impossible for the Contractor to perform the said contract within the contractual date for completion; Viz.

On account of the project being suspended from January 19, 1939 to April 13, 1939 due to inclement weather and time lost in awarding of Contract No. 2.

WHEREAS, it appears the said Contractor is not responsible for such delay in the completion of said Contract and,

NOW THEREFORE, BE IT HEREBY RESOLVED BY the County Commissioners of Carbon County:

(1) that the date for completion of the said contract be extended 109 days;
