R.G.Engstrom, being the duly elected,qualified and acting Clerk of Carbon County,Wyoming, and Ex-Officio Clerk of the Board of County Commissioners of said County, do hereby certify the following to be a true copy of the approval of the extention of time as shown in the minutes of the regular meeting of the Board of County Commissioners held January 5,1939.

"A resolution was offered by Commissioner Hansen and unanimously adopted whereby Harry J. Cashman was granted an additional extention of time of fifteen (15) days or until January 23, 1939 to complete his Contract No.1, Docket Wyoming 1083-F, as the said contractor has been delayed in the progress of the work owing to its nature and to the fact that about twenty inches of frost is encountered which retards excavation operations. This extention of time will not affect the operations of any other principal contractor, and

WHEREAS, Contract No. 1 does not stipulate liquidated damages, and the County of Carbon does not anticipate any damages caused by this extention of time, liquidated damages are hereby waived, and
