

SPECIAL MEETING.

The Board of County Commissioners met in special session this 20th day of January A. D. 1939, at 10:00 o'clock A. M., all members of the Board present, Fred F. Hansen presiding.

County Attorney J. J. Hickey and Attorney D. R. Higley met with the Board to discuss Judgement rendered against Carbon County by the District Court in favor of Joseph Budd.

It appearing that in the case of Budd versus Carbon County Commissioners pending in the District Court for this County, a judgment has been rendered in favor of Mr. Budd, the plaintiff, for a sum in excess of one thousand dollars; and it further appearing that it is proper to appeal said decision to the Supreme Court of Wyoming and that said appeal should be rendered on behalf of the County by the former County Attorney who is familiar with the case, and the former County Attorney, D. R. Higley, having offered to accept \$250.00 as attorney's fees in said appeal,

It Is Moved that said case be appealed to the Supreme Court of Wyoming and that D. R. Higley be employed to prosecute the appeal for the sum of \$250.00, the County to pay the actual costs of the appeal. Said motion duly seconded and unanimously carried.

Architect Frederic H. Porter, together with Resident Engineer Apple, the County Surveyor S. S. Sharp, inspected and approved the excavation made at New Court House site. Same was also approved by Fred F. Hansen, Chairman of the Board.

At the suggestion of Mr. Frederic H. Porter, Clerk of the Works, Archie Hansen was released from his duties as present contract has been completed.
