

COMMISSIONERS' PROCEEDINGS

The Board of County Commissioners met this 7th day of February, A. D. 1939, at 10:00 o'clock A. M., all members present, Fred F. Hansen presiding.

Monthly reports of County Officers were read, approved and ordered placed on file.

Delegation composed of the following men met with the Board to again discuss coal for heating the New Court House Building. Glenn Knox, H. C. Marchant, L. W. Mitchell, I. N. Bayliss, F. A. Hunter, and F. R. O'Donnell of Rock Springs, Wyo. S. D. Briggs, O. G. Sharer, Norman Smith and C. D. Williamson of Hanna, Wyo., and Chas. Earner, John Griffin, S. E. Tolliver, and Fred Sforza of Rawlins, Wyo. Talks were made by several members of the delegation. It was agreed by the Board and members of the delegation that another meeting will be held before the bids for the New Court House building will be opened on March 7th, 1939.

Delegation of the following Rawlins and Saratoga business men met with the Board to discuss the proposed Snowy-Range-Centennial Highway. F. H. Healy, Bert Peck, Ed Shively, Clark Nuhn, L. Donelon, Dr. Ray Corbett, Clarence Shaw, Earl Moore, George Fryer and Andy Anderson, of Saratoga. H. Breitenstein, Roscoe Alcorn and John Ingraham of Rawlins. After a lively discussion, a motion was made by Commissioner McCarthy, and seconded by John Gooldy, that report of Board of Appraisers be accepted and warrants be drawn for the amounts as set by the Board of Appraisers. Thereupon the Board adjourned until Thursday February 9th, A. D. 1939 at 10:00 o'clock A. M.

The Board resumed its session on Feb. 9th, 1939 at 10:00 o'clock A. M. all members present-Fred F. Hansen

Presiding. On motion by McCarthy, second by Gooldy, resolution was passed regulating fees to be paid for stock inspection as follows:

One to twenty head to be paid at the rate of 25¢ per head.

Twenty head to fifty head at the rate of 20¢ per head and all over fifty head-15 ¢ per head. Mileage will also be paid to points of inspection and this schedule goes in effect at once, superceding all other schedules.

On action duly taken by the Board, it was decided that all County Officers and employees in the County Shop, be furnished with requisition books for the ordering of repairs and supplies. These forms to be used when ordering repairs or supplies in the amount of \$5.00 or over, requisition to be signed by a member of the Board or the County Clerk. All merchants are required to attach such requisitions to their statements when rendering same the end of each month.

The following resolution was unanimously adopted by the Board.

RESOLUTION

WHEREAS, the UNION PACIFIC RAILROAD COMPANY has tendered to the COUNTY OF CARBON, STATE OF WYOMING, an agreement extending to February 29, 1944, the term of contract dated August 9, 1934, granting to the County certain rights for highway purposes in portions of the Railroad Company's right of way in Carbon County, Wyoming; said agreement being identified as Union Pacific Railroad Company's Contract Department No. 9221-D; and

WHEREAS, the Board of County Commissioners of the County of Carbon has said proposed agreement before it and has given it careful review and consideration; and

WHEREAS, it is considered that the best interests of said County of Carbon will be subserved by the acceptance of said agreement:

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING:

That the terms of the agreement submitted by the Union Pacific Railroad Company as aforesaid be, and the same are hereby, accepted in behalf of the County of Carbon, State of Wyoming:

That the Chairman of the Board of County Commissioners of said County is hereby authorized, empowered and directed to execute said agreement on behalf of said County, and that the County Clerk is hereby authorized and directed to attest said agreement and to attach to each duplicate original of said agreement a certified copy of this resolution.
