

COMMISSIONERS' PROCEEDINGS

Board of County Commissioners met March 7, 1939 at ten o'clock A. M. all members present, Fred F. Hansen presiding.

Two delegations representing the coal industry and Rocky Mountain Gas Company met with the Board to again discuss the heating of the new Courthouse building. Mr. Frederic H. Porter, Architect, acted as Chairman at request of Chairman of Board of Commissioners, Mr. Hansen. Heating costs and other data were presented at this hearing by both groups. It was finally decided that decision could not be rendered by the Board until the bids for the new building are opened, to ascertain whether or not enough money would be available to make any necessary alterations, in event a change in heating plans is decided upon.

By unanimous vote of the Board, \$50,000.00 was appropriated for the 1939 Road & Bridge Fund and included in 1939 Budget of anticipated County expenditures.

Bids for construction of the new Courthouse building were opened promptly at 2:00 o'clock P. M. in presence of Fred F. Hansen, Chairman of Board of Commissioners, Commissioner McCarthy, Commissioner Gooldy, County Clerk Engstrom, County Attorney J. J. Hickey, County Surveyor S. S. Sharp, P. W. A. Resident Engineer E. F. Apple, and Architect Frederic H. Porter. Bids were opened by County Clerk R. G. Engstrom and read by Mr. Porter and Mr. Apple. Following bids were received:

CARBON COUNTY COURTHOUSE
RAWLINS WYOMING
RESOLUTION AWARDING CONTRACT

WHEREAS the County of Carbon in the State of Wyoming pursuant to an advertisement for bids for the construction of a proposed Courthouse and Jail Building to be constructed at Rawlins, Wyoming, herebefore published on February 1, 8, 15 and 22, 1939, did on the Seventh day of March, 1939, at two o'clock p. m., in the auditorium of the Central School Building, adjacent to the present County offices, Rawlins, Wyoming, receive bids for the construction of a Courthouse and Jail Building, which said bids were taken under advisement by the Board of County Commissioners, the County Attorney, and the Architect.

WHEREAS, the base bid of the Spiegelberg Lumber and Building Company, of Laramie, Wyoming, for the complete general work, when reduced by Alternate Bid No. 2A, is the lowest bid submitted by any responsible bidder;

Now, therefore, be it resolved, that the contract for such work be awarded to the Spiegelberg Lumber and Building Company for the sum of \$257,500.00, such amount being determined by the acceptance of the base bid and Alternate Bid No. 2A. Provided, however, that this award shall not be effective until the contractor, the Spiegelberg Lumber and Building Company, shall have been notified in writing by the County Clerk of such award.
