

COMMISSIONERS' PROCEEDINGS  
SPECIAL MEETING

The Board of County Commissioners met this fifth day of August, A. D. 1940 at ten o'clock a. m., all commissioners present, together with County Assessor, William A. Johnson, Fred F. Hansen presiding, and J. J. Hickey, County Attorney.

Pursuant to the provisions of law, the Board of Commissioners met August 5, 1940 for the purpose of fixing the tax levies for and within the County of Carbon, State of Wyoming, for the year 1940.

Having received from the State Board of Equalization notice that the assessed valuation of Carbon County for the year 1940 had been found to be \$26,163,828.00 and that the state tax levy applicable to all assessed property within the state had been fixed at one and one-half mills, (1.5); and that the County Assessor had advised the Board of the assessed valuation of each of the various municipalities and school districts within the County, the Board proceeded to fix the levies upon the assessed property of Carbon County for the year 1940 as follows:


