

COMMISSIONERS' PROCEEDINGS.

The Board of County Commissioners met this 2 day of January A. D. 1940, at 10:00 o'clock A.M. with all members present, Fred F. Hansen presiding.

Reports of County officers for month of December 1939 were approved and placed on file.

Tax abatement in the amount of \$120.78 was allowed Kathryn Sowder Enberg account of erroneous assessment.

On motion by Commissioner McCarthy, seconded by Gooldy, R. G. Engstrom was appointed as County Purchasing agent for 1940. It was decided by the Board, that no bills will be paid unless a purchase order has been issued. The merchant receiving the order is required to attach same to his statement when presented to the County for payment. All orders must be signed by the purchasing agent or a member of the Board of Commissioners. It was also agreed that all orders for \$100.00 or over, be signed by a member of the Board.

The appointment of C. B. Jensen as Deputy assessor to assist in the revaluation of new buildings in Rawlins was approved by the Board.

Thereupon the Board adjourned until Jan. 3, 1940.
