

## COMMISSIONERS' PROCEEDINGS

## SPECIAL MEETING.

The Board of County Commissioners met this 15th day of March A. D. 1940 at 2:00 o'clock P. M. with all members present, Fred F. Hansen.

The minutes of the last meeting were read and approved.

Sealed proposals for beds and bedding for jury quarters were received from the following firms.  
H. Rasmussen Inc.      Modern Furniture Co.      Ferguson Mercantile Co.

On examination of the bids, and comparison of prices and specifications, the bids were awarded to H. Rasmussen Inc. and Ferguson Mercantile Co.

L. E. Wright of Ten mile, applied for a beer license for March 17, 1940 only. On motion by Commissioner McCarthy and seconded by Gooldy, this license was granted by the Board.

The Board of Commissioners in company with E. F. Sullivan, Resident P. W. A. Engineer, Frederic H. Porter, Architect and County Attorney J. J. Hickey, inspected the new Courthouse and Jail Building.

Motion was made by Commissioner Gooldy and seconded by McCarthy, accepting Architect Porter's recommendation of the substantial completion of Spiegelberg Lumber & Building Co. contract, for the construction of the new Courthouse and Jail Building.

On motion duly made by Commissioner McCarthy and seconded by Gooldy, June 8, 1940 was set as the date for the official dedication of the New Courthouse and Jail Building, and County Attorney J. J. Hickey was appointed as Chairman of all necessary arrangements.

Motion was duly made by Commissioner McCarthy and seconded by Gooldy and unanimously carried, authorizing advertising of call for bids as follows:

## CALL FOR BIDS.

Sealed proposals for the following separate contracts A. Landscaping, B. Construction of Garage, C. Walks and Curbing, and D. Installation of Elevator for the Carbon County Courthouse and Jail Building for the County of Carbon at Rawlins, Wyoming will be received in the Commissioners Office of the new Carbon County Courthouse Rawlins, Wyoming, until 2:00 o'clock P.M. Monday, April 8, 1940, and then will be publicly opened and read.

All bids shall be made on the printed forms attached to and made a part of the proposed contract documents. The Contract documents may be examined at the office of the consulting architect, Frederic Hutchinson Porter, 211 West 19 Street, Cheyenne, Wyoming, from whom the said contract documents may also be obtained.

Each bidder must submit with his bid a certified check, or bid bond equal to five (5%) per cent of his bid, and the check of the successful bidder or bidders shall be retained by the Owner until delivery of material is completed and all work completed.

No bidder may withdraw his bid for at least thirty days after the scheduled closing time for the receipt of bids.

Preference, as required by State law, is hereby given to materials, supplies, and provisions produced, manufactured, or grown in Wyoming, quality being equal to articles offered by competitors outside of the State.

The Board of County Commissioners of Carbon County reserve the right to reject any or all bids and to waive informalities.
