Regular Meeting

The Board of Commissioners met July 1, 1941 at 10 A.M. all present, John F. Gooldy presiding.

The minutes of meetings held May 26th and June 3rd were read and approved.

There being no protests entered to the applications of Ten Mile Inc. for a Liquor License, and J. N. Crane of Walcott Filling Station for a Malt Beverage License, a motion was made by Commissioner Hansen and seconded by McCarthy that licenses be granted. License No. 17 was issued to Ten Mile Inc. for \$300.00, and License No. 80 issued to J. N. Crane for \$100.00.

A motion was made by Commissioner McCarthy and seconded by Hansen, granting a series of six, Sunday beer licenses to Curt Brown of Ten Mile Inc. at rate of \$10.00 each.

The Board met in regular session July 2, 1941, at 10 A.M. all present, John F. Gooldy presiding.

The following school treasurers' bonds were approved and delivered to the County Treasurer.

Arthur H. Paris School District No. 14 \$1000.00 and A. A. Hooker School District No. 33 \$2000.00

An application was received from J. N. Crane of Walcott Service Station for six special Sunday beer licenses. A motion was made by McCarthy and seconded by Hansen authorizing the County Clerk to issue six licenses at \$1.00 each, commencing July 20, 1941.

The monthly reports of County Officers were approved and placed on file.

The following County property was sold and Commissioners Deeds issued for same.

The applications of Clarence Lucas of Hanna and Eileen Dodge of Saratoga for Scholarship awards were considered by the Board. The Board unanimously awarded each applicant a Wyoming University scholarship for the 1941-1942 term.

Thereupon the Board adjourned until July 3, 1941.

The Board reconvened July 3, 1941 at 10 A.M. all members present; John F. Gooldy presiding.

Several matters of routine County business were disposed of.

The Board rescinded the action taken at regular meeting of June 5, 1941, wherein \$750.00 was appropriated to supplement the District Court budget, account of payment from Natrona County having been received to defray the expense of the Dan Eagan trial; this amount was paid out of Carbon County District Court funds, which depleted the budget. The following tax abatements were allowed by the Board.
