

COMMISSIONERS' PROCEEDINGS

REGULAR MEETING

THE BOARD OF COMMISSIONERS MET JANUARY 7, 1941, AT 10:00 O'CLOCK A. M., ALL MEMBERS PRESENT, FRED F. HANSEN PRESIDING.

THE MINUTES OF MEETING HELD DECEMBER 27, 1940 WERE READ AND APPROVED.

BUDGET OFFICER, R. G. ENGSTROM, REPORTED TO THE BOARD OF COMMISSIONERS THAT DUE TO THE LARGE SUM EXPENDED FOR RODENT CONTROL DURING 1940 AND TO VARIOUS OTHER EXPENSES THAT WERE INCURRED IN CONNECTION WITH CONSTRUCTION OF THE NEW COURT HOUSE & JAIL BUILDING, THE "OTHER" MISCELLANEOUS ACCOUNT IN THE MISCELLANEOUS FUND HAD BECOME DEPLETED. IT WAS SUGGESTED THAT THE SUM OF \$3231.68 BE APPROPRIATED TO COVER THIS OVER DRAFT. ON MOTION BY COMMISSIONER GOOLDY, SECONDED BY McCARTHY, AND UNANIMOUSLY CARRIED, \$3231.68 WAS APPROPRIATED OUT OF THE UNAPPROPRIATED REVENUES IN COMPLIANCE WITH SECTION 11, CHAPTER 87, SESSION LAWS OF WYOMING, 1939.

THEREUPON THE BOARD OF COMMISSIONERS ADJOURNED, SINE DIE.

THE BOARD OF COUNTY COMMISSIONERS MET JANUARY 7, 1941, AT 10:30 O'CLOCK A. M., FOR THE PURPOSE OF REORGANIZING THE BOARD.

BY UNANIMOUS ACTION OF THE BOARD, JOHN F. GOOLDY WAS APPOINTED TEMPORARY CHAIRMAN.

A MOTION WAS MADE BY COMMISSIONER HANSEN, AND SECONDED BY McCARTHY, THAT COMMISSIONER GOOLDY BE ELECTED PERMANENT CHAIRMAN OF THE BOARD OF COMMISSIONERS FOR A TERM OF TWO YEARS.

ON MOTION BY COMMISSIONER HANSEN, SECOND BY McCARTHY, DR. R. V. BATTERTON WAS APPOINTED THE COUNTY PHYSICIAN FOR A TWO YEAR TERM.

COMMISSIONER McCARTHY WAS UNANIMOUSLY REAPPOINTED BY THE BOARD AS A MEMBER OF THE CARBON COUNTY WELFARE BOARD FOR A FOUR YEAR TERM.

THE MONTHLY REPORTS OF COUNTY OFFICERS WERE AUDITED AND APPROVED AND PLACED ON FILE.

THE BOARD RESUMED ITS SESSION JANUARY 8, 1941, AT 10:00 O'CLOCK A. M., JOHN F. GOOLDY PRESIDING.

"A MOTION WAS MADE BY COMMISSIONER McCARTHY, SECONDED BY HANSEN AND UNANIMOUSLY CARRIED, ADOPTING THE FOLLOWING RESOLUTION:

WHEREAS, REQUEST HAS BEEN MADE FOR THE ESTABLISHMENT OF A COUNTY ROAD RUNNING NORTHEASTERLY FROM THE TOWN OF HANNA; AND

WHEREAS, SAID ROAD HAS BEEN LOCATED BY THE UNION PACIFIC COAL COMPANY, AND SAID COMPANY HAS PROMISED AN EASEMENT OVER THE PORTION OF THE RIGHT-OF-WAY CONTROLLED BY THEM;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY THAT SAID ROAD BE ESTABLISHED AND DECLARED A COUNTY ROAD, THE CENTER LINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT NEAR THE SOUTHWEST CORNER OF SEC. 17, TWP. 22 N. R. 81 W., LOCATED N. 74° 18' W. 32.6 FEET FROM THE SOUTHWEST CORNER OF SAID SEC. 17;

RUNNING THENCE IN A GENERAL NORTHEASTERLY DIRECTION THROUGH THE FOLLOWING LANDS:

W₁¹SW₄¹, NW₁¹, NW₁¹NE₄¹, SEC. 17; S₂¹SE₄¹, NE₁¹SE₄¹, SE₁¹NE₄¹, SEC. 8; AND W₂¹NW₄¹, SEC. 9, TWP. 22 N. R. 81 W;

TERMINATING AT POINT ON THE NORTH LINE OF SEC. 9, TWP. 22 N., R. 81 W., LOCATED S. 89° 43' EAST 468.3 FEET FROM THE NORTHWEST CORNER OF SAID SEC. 9;

THE RIGHT-OF-WAY FOR SAID ROAD TO BE 100 FEET IN WIDTH, BEING 50 FEET ON EACH SIDE OF THE ABOVE DESCRIBED CENTER LINE, EXCEPT THROUGH THE W₁¹SW₄¹ SEC. 17, WHERE THE WIDTH IS TO BE 50 FEET, BEING 25 FEET ON EACH SIDE OF THE CENTER LINE.
