TAX ABATEMENTS AND REBATES as follows were granted by the Board.

Frank J. Walker, Medicine Bow, tax abatement, \$10.70, account homestead exemption.

Phillip B. Zingsheim, Rawlins, tax abatement, \$16.97, account homestead exemption.

Mrs. Bertha Clark, Encampment, tax abatement, \$16.22 and tax rebate/No. 1442 of \$2.92, account homestead exemption.

C. E. Hansen, Rawlins, tax rebate, \$4.00, account double payment of poll tax, No. 1443.

Isaac Kilgore, Baggs, tax rebate, No. 1444, \$5.29, account erroneous assessment.

Lower Snake River T. & T. Co., Baggs, tax rebate, No. 1445, \$2.93, account erroneous assessment.

Whereas, it appears that on September 17th, 1942, and in accordance with the requirements of said Order of said Board of County Commissioners, the Town Clerk of the Town of Parco, posted a Proclamation of said Election in three public places in the Town of Parco, and that said Proclamation remained posted until and including November 3rd 1942; and it is further shown that in compliance with said Order the Town Clerk of the Town of Parco caused said Proclamation to be published in the Rawlins Republican, a newspaper of general circulation in Carbon County, Wyoming, on the 14th and 21st days of October, 1942, respectively and

Whereas, pursuant to said Order of the Board of County Commissioners of Carbon County, Wyoming, and said Proclamation of election, the proposition of changing the name of Town of Parco, to Town of Sinclair was submitted to a vote of the qualified electors of said Town of Parco at the General Election held in said Town of Parco on November 3rd, 1942; and when said polls were closed the Judges and Clerks of said election in said Town of Parco canvassed the ballots so cast at said election on the proposition aforesaid, and certified the results of said election, such canvass and Certificate showing that 287 votes had been cast on said proposition, with the result that 201 votes were cast for change of name from Town of Parco to Town of Sinclair and 85 votes had been cast "Against" such change of name, and that one vote was void, and

Whereas, at the meeting of the Canvassing Board held on November 16th, 1942, the votes cast on said proposition at said election were canvassed and found and they declared the result as reported by the Judges and Clerks of said election in the Town of Parco to be correct, and

Whereas, it is the wish and desire of the Town of Parco acting through its Mayor and Town Clerk that the Board of County Commissioners of Carbon County, Wyoming, make an Order declaring that the official name of the Town of Parco has been changed to the Town of Sinclair, and that all business of all County Officers having to do with the Town of Parco, shall, on and after January 1st, 1943, be conducted with said Town under the name of Town of Sinclair.

L. E. Armstrong appeared before the Commissioners in the matter of the change of name of the Town of Parco to Town of Sinclair. A motion was made by Commissioner McCarthy, seconded by Gooldy and so carried, whereby it was ordered that the official name of the Town of Parco be and is hereby changed to the Town of Sinclair, said change to become effective from and after the 1st day of January, 1943.

ORDER OF THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING
Re CHANGE OF NAME OF TOWN OF PARCO TO
TOWN OF SINCLAIR.

At the Regular Meeting of the Board of County Commissioners held in Rawlins, Wyoming, the following recitals and Order was made by unanimous vote and Ordered spread upon the minutes of the Board.

Whereas it appears that on the 9th day of September 1942, the Town Council of the Town of Parco adopted appropriate preambles and resolutions authorizing and directing the Mayor and Town Clerk of the Town of Parco for and on its behalf

(1) To petition the Board of County Commissioners of Carbon County Wyoming, for an Order authorizing the submission of the proposition to change the name of the Town of Parco to the Town of Sinclair to a vote of the qualified electors of the Town of Parco at the next general election to be held thereat on the 3rd day of November 1942, and

(2) To do and perform any and all other acts which they or either of them might deem necessary or advisable in order to carry out the intent and purpose of said resolutions, and

Whereas, pursuant to said resolutions and on September 10th, 1942, the Town Council of the Town of Parco, acting through its Mayor and Town Clerk filed an Amended Petition with the Board of County Commissioners, of Carbon County, Wyoming, requesting the submission of said proposition to a vote of the qualified electors at the General Election to be held in Parco on the 3rd day of November 1942; and

Whereas, on the 11th day of September, 1942, at an adjourned meeting, and after considering said petition the Board of County Commissioners of Carbon County, Wyoming, made and entered an Order that an election be held in the Town of Parco, Carbon County, Wyoming, on the 3rd day of November 1942, for the purpose of submitting to the qualified electors of said Town of Parco, the proposition of changing its name to Town of Sinclair, to determine if a majority of said electors were favorable to such change, and

Thereupon, on motion duly made, seconded and unanimously carried the following Order is hereby entered upon the minutes of the Board this 1st day of December, 1942.

It is hereby Ordered by the Board of County Commissioners of Carbon County, Wyoming, that the official name of the Town of Parco, be and is hereby changed to the Town of Sinclair said change to become effective from and after the 1st day of January, 1943.

It is further Ordered that from and after the said 1st day of January, 1943, that any and all business heretofore and now being conducted by any and all County Officials shall be carried on and conducted with said Town under the Official name of Town of Sinclair.

Thereupon the Board adjourned until December 3, 1942.

The Board resumed its session December 3, 1942, all present, John F. Gooldy presiding.

By the unanimous action of the Board the following amounts were appropriated from the Emergency Fund to cover the deficits in various budgets at the request of the Officers at the head of these departments. County Coroner \$154.83; Livestock Inspection \$234.56; Elections \$495.80 and Health Office \$203.19.

Several matters of routine county business were disposed of.

Thereupon the Board adjourned until December 4, 1942.
