An application was received from the Carbon Power & Light, Inc., of Saratoga, Wyoming, requesting permission to construct power lines and lateral feeders along and across county and state highways.

Pursuant to your application dated February 3, 1942, it was duly moved, seconded and adopted by the Board of County Commissioners of the County of Carbon, State of Wyoming, this day, that the request contained in said application be granted, and that the Carbon Power & Light, Inc., its successors and assigns, be permitted to construct, maintain and operate its proposed electrical power transmission line and the lateral feeders therefrom in southeasterly direction from northwest of Parco, Wyoming, on, over, along and across U. S. Highway No. 30, U. S. Highway No. 287, State Highway No. 130 and the

county roads embraced within the following area in Carbon County, Wyoming, to-wit:

Township 21 North, Ranges 85 and 86 West of the 6th P. M.

Township 20 North, Ranges 84, 83, 82, 81, 80, and 85 West
of the 6th P. M.

provided, however, that the construction, maintenance and operation of said lines and feeders
shall not interfere with the rights of the public to use said highways and roads for the purpose
of travel.
