

COMMISSIONERS' PROCEEDINGS
SPECIAL MEETING

The Board of Commissioners met Aug. 2, 1943, at 10:00 o'clock A. M. all members present, together with County Assessor Wm. A. Johnson, for the purpose of fixing the Tax Levies for and within Carbon County for the year 1943 in compliance with Sec. 115-135 W. R. S. 1931.

Having received from the State Board of Equalization notice that the assessed valuation of Carbon County for the year 1943 had been found to be \$29,573,084.00; the County Assessor advised the Board of the assessed valuation of each of the various municipalities and school districts within the County, the Board proceeded to fix the levies upon the assessed property of Carbon County for the year 1943 as follows:
