## REGULAR MEETING

#### NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming, have decided to locate a road to be known as Rawlins-Muddy Gap Road; commencing at a point which is on the South line of Section 8, T. 21 N., R. 87W., being 1464.6 feet West of the SE corner of said Section 8 when measured along said South line; thence in a Northerly direction thru Sections 8, 9 and 4, T. 21 N., R. 87W., Sections 33, 32, 29, 30, 20, 19 and 18, T. 22 N., R. 87W., Sections 13, 12, 1 and 2, T. 22 N., R. 88W., Sections 35, 34, 27, 28, 21, 16, 17 and 8, T. 23 N., R. 88W., all of the 6th P.M., Wyoming to a point in the NE $\frac{1}{4}$  of said Section 8.

The proposed location and width of right of way required are set forth in detail on map on file with the County Clerk and may be examined at his office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said county before noon on the 5 day of January A.D., 1944, or such road will be established without reference to such objections or claims for damages.

CERTIFICATE of PURCHASE No. 3314 was cancelled by order of the Board of Commissioners.

The Board unanimously approved an additional appropriation of \$85.76 for the County Superintendent of Schools' budget from the Emergency Fund to cover a deficit which was caused from high costs of supplies necessary for the operation of this office.

The Wyoming Game & Fish Commission was authorized to place a building about 20 feet square inside of the fence at County Shops. The site for said building to be designated by the Board of Commissioners.

There being no further business, the Board adjourned until Dec. 20, 1943, at which time the tentative budget for 1944 will be received and considered.
