

# COMMISSIONERS' PROCEEDINGS

## Special Meeting

The Board of Commissioners met Jan. 4, 1943, at 10:00 o'clock A. M. Gooldy and McCarthy present, Fred F. Hansen absent.

The minutes of meetings held on Dec. 1,2,3 and 4 were read and approved.

Thereupon the old board of Commissioners adjourned sine die.

The Board of Commissioners met at 10:30 A. M. for the purpose of organizing the new Board, there being present Commissioners Gooldy, McCarthy and Cheesbrough.

By the unanimous action of the Board, John F. Gooldy was appointed temporary Chairman.

A motion was made by Commissioner Gooldy and seconded by Cheesbrough and carried, that Eugene McCarthy be elected permanent Chairman of the Board of Commissioners for the ensuing two year term.

JUSTICE OF THE PEACE, MEDICINE BOW, JUSTICE PRECINCT NO. 4. A motion was made by Cheesbrough, seconded by Gooldy and carried, whereby David W. Ellis was appointed Justice of the Peace in Medicine Bow to fill the vacancy of Glen W. Knudson who failed to qualify, same being for a four year term.

JUSTICE OF PEACE PRECINCTS CONSOLIDATED. A motion was made by Gooldy, seconded by Cheesbrough and carried, whereby Justice precinct 1-A, and justice precinct 1-B were consolidated, Justice Waeckerlin presiding in the consolidated district comprising all of Rawlins voting precincts, Ft. Steele, Walcott, Sinclair, Lamont, Seminole Dam, Marvin and Station 8.
