One County Commissioner for a term of four years.

Party Committeemen for each Election Precinct.

One Councilman for Ward One, City of Rawlins.

One Councilman for Ward One, unexpired term, City of Rawlins.

One Councilman for Ward Two, City of Rawlins.

One Councilman for Ward Three, City of Rawlins.

One Councilman for Ward Three, unexpired term, City of Rawlins.
