SCHOOL BOND of Lois Schoonjans, Treasurer, School District #17 for \$1,000.00 was approved.

APPOINTMENT of Mary E. Wood as Deputy Clerk of Court, effective December 1, 1944, was unanimously approved by the Board.

RESOLUTION: A resolution was made by Commissioner Gooldy, seconded by Cheesbrough, and unanimously carried, whereby \$2,500.00 of the County Fair Fund was invested in U. S. Sixth War Loan Bonds. The County Treasurer was authorized to make this purchase.
