June 6, 1945

The Board resumed its session June 6, 1945, all present.

APPOINTMENTS:

The appointment of Eileen Feser and Margaret F. Sanden as Deputy County Clerks by R. G.

Engstrom was confirmed by the Board of Commissioners and bonds approved in the amount of \$1500.00.

E. P. (Pat) Murphy was unanimously appointed as a member of the Carbon County Memorial

Hospital Board, effective July 1, 1945 for a five-year term.

MALT BEVERAGE LICENSES:

There being no protests entered, the Board unanimously decided to grant the following licenses:

- Malt Beverage License No. 106 - R. L. Tully, Muddy Gap Service Station \$100.00

A motion was made by Commissioner Cheesbrough, seconded by Gooldy, and unanimously carried, whereby Liquor License No. 24 issued to E. F. Kiehl and P. A. Bocek of Lamont on May 2, 1945 was transferred to E. F. Kiehl, Mr. Kiehl having purchased Mr. Bocek's interest in the Lamont Bar.

June 7, 1945

The Board met at 10:00 a. m. June 7, 1945, all present.

BRUSH CREEK-SARATOGA ROAD

The matter of the Brush Creek-Saratoga road was called to the attention of the Board of Commissioners by County Clerk, R. G. Engstrom, and it was the general consensus of opinion after the discussion that the proceedings in connection with the establishment of said road were irregular and that the appraisers' report was not a true report of actual damages and should have been reduced in the amount allowed land owners affected by said road location.

It was regularly moved by John Gooldy, seconded by John Cheesbrough and unanimously carried that all of the proceedings in connection with the establishment and location of the Brush Creek-Saratoga road, Project No. FAS 14 B (1) 1943. County No. CB-5, instituted under date of March 8, 1945 be, and all proceedings in connection therewith are hereby rescinded and expunged to the same extent as if no proceedings had ever been instituted to establish said road.

It was regularly moved by Commissioner Gooldy, seconded by Commissioner Cheesbrough and unanimously carried that the Board of County Commissioners adopt the following resolution:

RESOLUTION TO LOCATE ROAD

Whereas, public necessity requires that the following described road be established by reason of the Brush Creek-Saratoga Road bridge over the Platte River being unsafe for large weights to travel over and the east approach being a curve and dangerous to travel and intersecting the Saratoga-Encampment Road at the base of a hill,

Now, therefore, be it resolved by the Board of County Commissioners that the following described road be located and established as follows, to-wit:

Project No. FAS 14 B (1) 1943
County No. Cb-5

NOTICE OF LOCATION OF PUBLIC ROAD

To Whom It May Concern:

The Board of County Commissioners of Carbon County, Wyoming, have decided to locate a section of the Brush Creek-Saratoga Road which will involve a relocation of approximately 0.9 mile and a new bridge crossing over the North Platte River south of Saratoga:

Commencing at a point in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 15, T. 16 N., R. 83 W. of the 6th P. M. Wyoming which point is S 57° 39' E, 1667.6 feet of a point which is S 74° 47' E, 180.0 feet of a point on the west line of said Sec. 15 from which point the W $\frac{1}{4}$ corner of said Sec. 15 is northerly 88.0 feet when measured along said west line; thence in a northwesterly direction thru the NE $\frac{1}{4}$ SW $\frac{1}{4}$ and NW $\frac{1}{4}$ SW $\frac{1}{4}$ Sec. 15, the NE $\frac{1}{4}$ SE $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$ and SE $\frac{1}{4}$ NW $\frac{1}{4}$ Sec. 16 all of T. 16 N. R. 83 W. of the 6th P. M. Wyoming to an interesection with the Saratoga-Encampment Road in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ said Sec. 16.

The proposed location and width of right of way required are set forth in detail on map on file with the County Clerk and may be examined at his office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 5th day of July, A. D. 1945, or such road will be established without reference to such objections or claims for damages.
