COMMISSIONERS' PROCEEDINGS
REGULAR MEETING

The Board of Commissioners met at 10:00 a.m. July 1, 1947, Cheesbrough and McCarthy present, Sullivan absent. The minutes of meetings held June 3, 4, 9, and 26, 1947 were read and approved.

TRANSFER OF FUNDS FROM CASH RESERVE:

In compliance with Section 20-811 of the Municipal Budget Act, Wyoming Compiled Statutes of 1945, as amended in the Session Laws of 1947, a Notice of Public Hearing on the proposed transfer of \$18,300.00 from the Cash Reserve Fund was published on June 14, 1947. There being no protests, a motion was made and unanimously carried whereby the County Treasurer and Budget Officer were authorized to transfer the funds to various department as shown below:
