RESOLUTION TO ALTER PUBLIC ROAD

RIVERSIDE-WALDEN ROAD
Project No. S-259

WHEREAS, public necessity requires that the following road be altered,

NOW, THEREFORE, be it resolved by the Board of County Commissioners that the following described road be located and established as follows, to-wit:

NOTICE OF ALTERATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Riverside-Walden commencing at a point which is S. $89^{\circ} 36'$ W. a distance of 1723 feet from a point which is N. $52^{\circ} 31'$ W. a distance of 1191.2 feet from a point on the East boundary of Sec. 2, T. 14 N., R. 82 W. which is 2211.1 feet North of the East $\frac{1}{4}$ corner of said Sec. 2; thence in an Easterly direction through Sec. 35, T. 15 N., R. 83 W.; thence in a Southeasterly direction through Sections 2 and 1, T. 14 N., R. 83 W. and through Sections 6, 7, 8, 17 and 16, T. 14 N., R. 82 W. to a point which is N. $40^{\circ} 36'$ W. a distance of 1420 feet, more or less, from a point on the South boundary of Sec. 16, T. 14 N., R. 82 W. which is 847.5 feet East of the South $\frac{1}{4}$ corner of said Sec. 16.

The proposed location and width of right of way required are set forth in detail on map on file with the County Clerk and may be examined at his office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 3rd day of September, A.D. 1947, or such road will be established without reference to such objections or claims for damages.



MONTHLY REPORTS of County Officers were approved and placed on file.


Several matters of routine County business were disposed of, after which the Board adjourned.
