COMMISSIONERS' PROCEEDINGS

Regular Meeting

The Board of Commissioners met Jan. 7, 1947, at 10:00 A. M., there being present John Cheesbrough, Chairman, Eugene McCarthy, and J. J. "Jack" Sullivan.

The minutes of the meeting held Jan. 6, 1947, were read and approved.

APPOINTMENTS:

The following appointments were unanimously made by the Board.

WELFARE BOARD, J. J. Sullivan was appointed as a member of the County Welfare Board for a two-year term to fill the vacancy of John F. Gooldy.

COUNTY SURVEYOR, S. S. Sharp of Saratoga was appointed as County Surveyor for the ensuing four-year term.

OFFICIAL PAPER, The Rawlins Daily Times was appointed as the official county newspaper for the ensuing two-year term.

JUSTICE OF PEACE SALARY FOR JUSTICE PRECINCT NO. 1.

It was called to the attention of the Board that the population in Justice Precinct exceeded 6,000 people.

A motion was made by McCarthy, seconded by Sullivan, and unanimously carried whereby the Justice of Peace salary for this Precinct be \$1200 per year.
