In compliance with Sec. 52-222, W. R. S., 1931, the Board was presented with the report of the Board of Appraisers on the Savery Slater Road in Carbon County, as follows:

TO THE HONORABLE BOARD OF COUNTY COMMISSIONERS
RAWLINS, WYOMING

We, the undersigned Board of Appraisers on the Savery-Slater Road hereby submit the following report:

Charles Morgan. We recommend that the claim for damages in the amount of \$2,000.00 be allowed, and that the Stock Driveway be constructed under the Savery Creek Bridge wide enough and high enough so that it will be passible for stock; and that regulation highway fences be constructed.

M. A. Groshart Estate. We recommend that the claim for damages be set at \$500.00 and that a suitable crossing be constructed and that gates, approaches and fences be constructed.

Robert H. Rasmussen. We recommend that the highway construct standard highway fences on both sides of the road and that no claim for damage be allowed; we also recommend that the proper approaches be made.

Homer W. Beeler. We recommend that proper approaches and fences be constructed and no damages be allowed.

Reader Cemetery Corp. We recommend that a road be graded and graveled leading into the cemetery.
