NOTICE OF PROPOSED CONSTITUTIONAL AMENDMENTS

Public notice is hereby given that at the general election to be holden in the State of Wyoming on November 2, 1948, the following proposed amendments to the Constitution of the State of Wyoming will be submitted to the electors of this State for adoption or rejection, as certified to this office by the Secretary of State:

PROPOSED CONSTITUTIONAL AMENDMENT NO. 1

Our State Constitution provides that vacancies in the State Legislature be filled by a special election. This proposed amendment, if adopted, would repeal this provision, and authorize the Legislature to provide by law for the filling of vacancies caused by death, resignation or other causes.

Proposal to amend the Constitution of the State of Wyoming by adding a new section to Article III to be designated as Section 51, relating to the filling of vacancies in either House of the Legislature of the State of Wyoming, which section reads as follows:

"Article III, Section 51. When vacancies shall occur in the membership of either House of the Legislature of the State of Wyoming through death, resignation or other cause, such vacancies shall be filled in such manner as may be prescribed by law, notwithstanding the provisions of Section 4, of Article III of the Constitution which is by this section repealed."

PROPOSED CONSTITUTIONAL AMENDMENT NO. 2

This proposed amendment to the Constitution of the State of Wyoming, allows cities and towns to increase their tax levies to Twelve (12) mills instead of the present maximum of eight (8) mills.

Proposal to amend the Constitution of the State of Wyoming by amending Section 6, Article XV thereof, relating to incorporated city and town tax levies, to read as follows:

"Article XV, Section 6. No tax shall be levied by or for any incorporated city or town exceeding twelve (12) mills on the dollar in any one year, except for the payment of its public debt and the interest thereon."

PROPOSED CONSTITUTIONAL AMENDMENT NO. 3

This proposed amendment of the Constitution of the State of Wyoming relates to the manner in which the State may engage in work of internal improvement and, if ratified by the electors of the State will add a new Section, Section II, to Article XVI of the Constitution, which will give the Legislature of the State of Wyoming the power to provide for the construction, maintenance and improvement of public airports, aircraft landing strips and related facilities, in whole or in part by the State, either directly or by extending aid to political subdivisions thereof, without first submitting the question of the State's authority to engage in such work of internal improvement to the people of the State, as is now required by Section 6 of said Article XVI.

Proposal to amend the Constitution of the State of Wyoming, by adding Section II to Article XVI of said Constitution, relating to the construction, maintenance and improvement of airports, aircraft landing strips and related facilities.

"Article XVI, Section II. The provisions of Section 6, Article XVI of this Constitution prohibiting the State from engaging in any work of internal improvement unless authorized by a two-thirds vote of the people, shall not apply to or affect the construction, maintenance or improvement of public airports, aircraft landing strips and related facilities, but the Legislature shall have power to provide for the construction, maintenance and improvement of public airports, aircraft landing strips and related facilities, in whole or in part by the State, either directly or by extending aid to its political subdivisions and notwithstanding said inhibition as to works of internal improvement, whenever grants of land or other property shall have been made to the State, especially dedicated by the grant to particular works of internal improvement, the State may carry on such particular works and shall devote thereto the avails of such grants, and may pledge or appropriate the revenues derived from such works in the aid of their completion and maintenance."

PROPOSED CONSTITUTIONAL AMENDMENT NO. 4

This proposed amendment to the Constitution of the State of Wyoming relates to state tax levies for the support of the public schools in the State and, if ratified by the electors of the State, will permit a state tax levy of not more than six mills on the dollar of the assessed valuation of the property in the State each year for such purpose.

Proposal to amend the Constitution of the State of Wyoming, by adding a new Section to Article XV to be designated as Section 15, relating to annual state tax levies for the support of the public schools in the State, which section is to read as follows:

"Article XV, Section 15. For the support of the public schools in the State there may be levied each year a state tax not exceeding six mills on the dollar of the assessed valuation of the property in the State."

PROPOSED CONSTITUTIONAL AMENDMENT NO. 5

This amendment shall supersede all provisions of the Constitution in conflict herewith. It will provide for the Legislature to authorize such Juvenile Delinquency and Domestic Relations Courts as may be needed.


Proposal to amend the Constitution of the State of Wyoming, by adding Section 29 to Article V of said Constitution, relating to the creation of Juvenile Delinquency and Domestic Relations Courts.

"Article V, Section 29. The Legislature may by general law provide for such Juvenile Delinquency and Domestic Relations Courts as may be needed, and for the number, qualifications and election of judges of such Courts. Appeals shall lie in such cases and pursuant to such regulations as may be prescribed by law. Such Courts shall have such jurisdiction as the Legislature may by law provide."
