CORRALS--COUNTY FAIR GROUNDS

A delegation of Rawlins businessmen, ranchers, and members of the Fair Board met with the Commissioners and J. J. Hickey, County Attorney, to discuss ways and means of financing the construction of pens at the fair grounds to be used during the annual feeder sale which will be held this fall in Rawlins. It was the opinion of Mr. Hickey that money from the fair building fund could be used for the construction of the necessary pens. A motion was then made by Commissioner Sullivan, seconded by McCarthy, and unanimously carried, authorizing the Fair Board to proceed with the building of pens and corrals. It was estimated that the cost would not exceed \$5,000.00 for 100 pens.

CASPER-MEDICINE BOW HIGHWAY

A delegation of Medicine Bow businessmen met with the Board relative to the Casper-Medicine Bow highway. It was recommended that the Commissioners from Carbon and Natrona Counties, together with Medicine Bow businessmen, meet with the Highway Commission to urge the beginning of construction of approximately twelve miles of highway north of Medicine Bow to the TB Ranch. The Board then decided to write to the Highway Superintendent for a meeting date with the Highway Commission.

BRUSH CREEK ROAD.

The commissioners met with R. W. Taylor and Gershom Barkhurst in regard to State aid on the Brush Creek road in Platte Valley. These men explained that this is a farm-to-market road which is used by many ranchers and should be improved as a Federal Aid Secondary road. The Commissioners decided to correspond with the State Highway Superintendent and to inform Mr. Taylor and Mr. Barkhurst of any future developments.

RAWLINS-MEDICINE BOW ROAD PROJECT FI-221 (2)

It was regularly moved by Commissioner Sullivan, seconded by McCarthy, and unanimously carried, that the Board of County Commissioners adopt the following resolution:

RESOLUTION TO LOCATE ROAD.

WHEREAS, public necessity requires that the following road be established;

NOW, THEREFORE, be it resolved by the Board of County Commissioners that the following described road be located and established as follows, to-wit:

RAWLINS-MEDICINE BOW PROJECT FI-221 (2)
CARBON COUNTY

NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Rawlins-Medicine Bow, commencing at a point which is N. 49°36'E., a distance of 1230.9 feet from a point on the west line of Section 4, T. 22N., R. 80W., of the 6th P. M. Wyoming, from which the southwest corner thereof bears S. 0°06'W., a distance of 1985.7 feet; thence, in a southwesterly direction through Sections 4, 5, 8 and 7, T. 22N., R. 80W.; Sections 12, 13, 14, 15, 22, 21, 20, 29 and 30, T. 22N., R. 81W.; Sections 25, 36, 35, 34 and 33, T. 22N., R. 82W.; Sections 4 and 5, T. 21N., R. 82W., to a point on the west line of said Section 5, from which point the southwest corner thereof bears S. 0°07'W., a distance of 476.1 feet.

The proposed location and width of right of way required are set forth in detail on Map on file with the County Clerk and may be examined at his office.

All objections thereto and claims for damages must be filed in writing with the County Clerk of said County before noon on the 7th day of April, A. D. 1948, or such road will be established without reference to such objections of claims for damages.
