RAWLINS-MEDICINE BOW ROAD - PROJECT NO. F I. 221 (2) - COUNTY NO. Cb. 1

At the regular meeting of the Board held March 4, 1948 a resolution was adopted to locate the above road. Protests and claims for damages were received until noon April 7, 1948. The following protests and claims for damages were received by the Board:

In compliance with Sec. 52-219 W. R. S. 1931, a motion was made by Sullivan, seconded by McCarthy and unanimously carried whereby A. E. Robertson, Frank Schilt and W. J. Scott were appointed as a Board of Appraisers to view and appraise the above mentioned road as proposed and make a report of their findings to the Board of County Commissioners as soon as practicable. It was suggested to the Board of Appraisers that they meet with State Engineer, John Walters, at Medicine Bow on April 12, 1948 and make their report to the Board of Commissioners on April 13, 1948 at which time this Board would hold a special meeting.

ROAD NORTH OF MEDICINE BOW:

The Commissioners met with Mr. G. T. Bath of the Wyoming Highway Department on April 6, 1948 relative to the general routing of the proposed Medicine Bow-Casper Road. This will be known as F.A.S. Rt. No. 102, State No. 207 and will extend northward from Medicine Bow a distance of 18.7 miles and has been included in the Federal Aid Secondary System. The Commissioners also agreed that if and when Federal Aid Secondary Route 102 is extended, that the general routing as shown on a map exhibited to the Board will be followed, providing the location in Natrona County is approved as shown in red on said map.

There being no further business, the meeting was adjourned until April 13, 1948.
