



SPECIAL MEETING

June 13, 1949

The Board of Commissioners met at 10:00 A.M., all members present, Jack Sullivan, Chairman.

ABANDONMENT OLD ROAD BETWEEN BAGGS AND SAVERY. The Board of Commissioners together with S. S. Sharp, County Surveyor, met at Baggs, Wyo. on June 9, 1949, to view and survey the various portions of the road on which protests were received on June 7, 1949. A motion was made by Commissioner Cheesbrough, seconded by McCarthy and unanimously carried whereby the following resolutions were adopted:

RESOLUTION

WHEREAS, the construction of the new state highway from Baggs, through Dixon to Savery, has made unnecessary the continuance of the present county road connecting the same towns; and

WHEREAS, notice of abandonment of said county road has been duly advertised, and protests have been heard and considered;

NOW THEREFORE, be it resolved, that the present county road from Baggs, through Dixon, To Savery, be, and is hereby declared abandoned, with the exception of the following portions, described as follows:

Portion 1.

Beginning at the northwest corner of the SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 5, Township 12 North of Range 91 West of the 6th P.M., being a point on the corporate limits of the Town of Baggs; running thence in a general easterly and southeasterly direction through Sections 5, 4 and 9 of aforesaid township and range to a point on the east line of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 9, where the old county road intersects the new state highway at Station 57+00 of the new highway.

Portion 2.

Beginning at the intersection of the old county road with the new state highway at the east line of Section 11, Township 12 North, Range 91 West of the 6th P.M., running thence northerly and easterly through Sections 11, 12, Township 12 North, Range 91 West, to the east line of said Section 12.
