
PROPOSED CONSTITUTIONAL AMENDMENT

Proposal to amend Section 6, Article XV of the
Constitution of the State of Wyoming, relating to
incorporated city and town tax levies.

This proposed amendment to the Constitution of
the State of Wyoming allows cities and towns to
increase their tax levies to twelve (12) mills
instead of the present maximum of eight (8) mills,
and if ratified by the electors, will read as follows:

"Article XV, Section 6. No incorporated city or
town shall levy a tax to exceed twelve (12) mills on
the dollar in any one year, except for the payment of
its public debt and the interest thereon."
