COMMISSIONER'S PROCEEDINGS
SPECIAL MEETING

The Board of Commissioners met at 10:00 A.M., all members present, Eugene McCarthy, Chairman.

The minutes of the meetings held June 5, 6, and 11 were read and approved.

COUNTY SURVEYOR'S BOND as submitted by S. S. Sharp was approved. \$1000.00

PASS CREEK ROAD. A protest and claim for damages was received by the Board from Chas. Vivion of the Rocky Mountain Sheep Company against location of this road on lines of survey submitted by S. S. Sharp, County Surveyor. ROAD

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Section 20-811 of the Municipal Budget Act, W.C.S., 1945, as amended in the Session Laws of 1947, a Notice of Public Hearing on the proposed transfer of \$4000.00 from the Cash Reserve Fund was published on June 12, 1951. A motion was made by Commissioner Salisbury, seconded by Cheesbrough, and unanimously carried whereby the following resolution was adopted to wit:

RESOLUTION

WHEREAS, the following budgets have become depleted due to unanticipated costs of supplies, road repairs, and supplies for Road and Bridge Department;

IT IS HEREBY RESOLVED, that the County Budget Officer and County Treasurer be authorized to transfer funds as follows: County Superintendent of Schools, \$300.00; Road and Bridge Department, \$3500.00; Water Commissioner, \$200.00.

Mr. Dorrell and Mr. Claude Thompson of the Utah Oil Refining Company met with the Board relative to repairs on the road from Medicine Bow to Kyle Field.

HOSPITAL BOARD: The resignation of E. Pat Murphy as a member of the Hospital Board was received and accepted by the Board. James A. Chapman was appointed to serve on the Hospital Board for a period of five years, starting July 11, 1951.

LIBRARY BOARD: Mrs. D. L. Rusk was appointed as a member of the County Library Board to succeed Mrs. Casia Daly Martinez who submitted her resignation, term from July 2, 1951 to July 2, 1952.
