REGULAR MEETING

The Board of Commissioners met at 10:00 A.M., all members present, Eugene McCarthy, Chairman.

The minutes of meetings held March 6 and 7 were read and approved.

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Section 20-811 of the Municipal Budget Act, W.C.S., 1945, as amended in the Session Laws of 1947, a Notice of Public Hearing on the proposed transfer of \$2500.00 from the Cash Reserve Fund; (Livestock Inspection Fund \$1200.00 and Miscellaneous Fund \$1300.00) was published on March 21, 1951. There being no protests a motion was made and unanimously carried whereby the County Treasurer and Budget Officer were authorized to transfer \$2500.00 to the above funds on account of unanticipated livestock inspection costs and officers bond premiums.
