COMMISSIONER'S PROCEEDINGS
REGULAR MEETING

The Board of Commissioners met at 10:00 A.M., all members present, Eugene McCarthy, Chairman.

The minutes of meetings held April 3, 4, 7 and 11 were read and approved.

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Section 20-811 of the Municipal Budget Act, W.C.S., 1945, as amended in the Session Laws of 1947, a Notice of Public Hearing on the proposed transfer of \$37,450.00 from the Cash Reserve Fund was published on April 17, 1951. A motion was made by Commissioner Salisbury, seconded by Cheesbrough, and unanimously carried whereby the following resolution was adopted to wit:

RESOLUTION

WHEREAS, the following budgets have become depleted due to unanticipated costs of supplies, additional equipment, criminal and court costs, and road repairs and supplies for Road and Bridge department;

IT IS HEREBY RESOLVED, that the County Budget Officer and County Treasurer be authorized to transfer funds as follows: County Clerk, \$4,000.00, County Treasurer, \$3,500.00, County Assessor, \$3,000.00, County Sheriff \$3,750.00, County Attorney \$1,100.00, County Coroner \$100.00, District Court \$5,000.00, Road and Bridge Department \$17,000.00.

The Board of Commissioners met at 9:30 O'Clock A.M., all members present, together with highway engineer, Talcott Moore, for the purpose of discussing the farm-to-market road program and future work on the Sage Creek Road. A motion was made by Commissioner Salisbury, seconded by Cheesbrough and unanimously carried whereby the following resolutions were adopted:

BRUSH CREEK ROAD

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

The road known as the Brush Creek Road extending from the State Highway known as FAS 14 Southerly to the Leonard Bridge over the North Platte River.
