POLL TAXES - In compliance with Section 32-406 of the WCS of Wyoming, 1945, the Board authorized the County Assessor to proceed with the collection of Poll Taxes for the year of 1952.

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Section 20-811 of the Municipal Budget Act, W.C.S., 1945, as amended in the Session Laws of 1947, a Notice of Public Hearing on the proposed transfer of \$1000.00 from the Cash Reserve Fund was published on December 22, 1951. A motion was made by Commissioner Salisbury, seconded by Cheesbrough, and unanimously carried whereby the following resolution was adopted to wit:

RESOLUTION

WHEREAS, the Livestock Inspection Budget has become depleted due to unanticipated costs of inspection;

IT IS HEREBY RESOLVED that the County Budget Officer and County Treasurer be authorized to transfer \$1000.00 from the Cash Reserve Fund to Livestock Inspection.
