COMMISSIONERS' PROCEEDINGS
SPECIAL MEETING

The Board of Commissioners met at 1:00 O'Clock p.m., all members, present, for the purpose of entering into an agreement with the State Highway Department for proposed changes and improvements in the Hanna-Leo-Alcova Road in Carbon County, under the Farm-to-Market Road Program. A motion was made by Commissioner Salisbury, seconded by Cheesbrough and unanimously carried, whereby the following resolution was adopted:

HANNA-LEO-ALCOVA ROAD

RESOLUTION

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

The Hanna-Leo-Alcova Road in Carbon County beginning at the northerly end of the Hanna-L Plane road and extending northerly and westerly along the presently established County road to Leo and thence northerly to the Carbon County line on the existing road to Alcova.

Grading, draining and surfacing.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.

I, the undersigned, County Clerk of Carbon County, State of Wyoming, do hereby certify that a legal meeting of the Board of County Commissioners at which a quorum was present, said Board adopted a resolution of which the foregoing is a full, true and complete copy.
