IT IS HEREBY RESOLVED that the County Budget Officer and County Treasurer be authorized to transfer the above mentioned fund.

SINCLAIR RIVER PUMP STATION ROAD: A letter was received from the Sinclair Refining Company requesting the Board of Commissioners to consider incorporating the road to the Sinclair River Pump Station and the Golf Course and Recreation Park into the County Road System. It was explained that this road is used by Stock Men and Sinclair Employees at the Pump Station, also for access to the picnic and recreation park by many groups of Carbon County residents. The Board decided to take this matter under consideration and to investigate same with the Sinclair Engineers. *Road*
