## SINCLAIR-SEMINOE DAM ROAD

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

A portion of the Sinclair-Seminole Dam road; beginning at the north Corporate limits of the Town of Sinclair and extending northeasterly for a distance of approximately eight miles; all in T. 21 N., R. 86 W., and T. 22 N., R. 86 W., 6th P.M., Carbon County, Wyoming.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
