MONTHLY REPORTS OF COUNTY OFFICERS were audited and placed on file.

Mrs. Lee Airheart of Baggs, Wyo., met with the Board to discuss needed improvements on portions of County Road.

A motion was made by Salisbury, seconded by Robertson and carried and the following letter of permission was given Mr. & Mrs. Lee Airheart. road

Permission is hereby granted by the Board of County Commissioners for you to construct and maintain and place cattle guards crossing the County Road on the north side of the Snake River between Baggs and Dixon, Wyoming. V

You are also permitted to construct and maintain fences off the cattle guard to the edge of the County right-of-way, including gates to by-pass vehicles and livestock that cannot use the cattle guard.

Location of these structures will be where the fence crosses the County road in Section 1, Township 12 North, Range 91 West, and at a point where the fence crosses the County road on the section line between Sections 5 and 6, Township 12 North, Range 90 West.

Thereupon the Board adjourned until the following day.

MEDICINE BOW-NORTH ROAD Wyoming Project S - 50 (8).

#### NOTICE OF LOCATION OF PUBLIC ROAD

##### TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as the Medicine Bow-North road, Wyoming Project S-50 (8).

Commencing at a point in Section 21, T. 24., R. 78 W. of the 6th P. M., Wyoming, which point is N. 5°41' W. a distance of 259.9 feet from a point which is N. 9°49' E. a distance of 2569.9 feet from a point on the south boundary of said section 21 from which the southwest corner thereof bears S. 89°50' W. a distance of 1052.3 feet; thence running in a northerly direction for a distance of approximately seven miles through Sections 21, 16, 17, 8, 9, 4 and 5, in T. 24 N., R. 78 W. and Sections 33, 28, 21 and 16, in T. 25 N., R. 78 W. of the 6th P. M., Wyoming,

to a point of ending on the west boundary of Section 16, T. 25 N., R. 78 W. from which the west quarter corner of said section 16 bears southerly a distance of 203.0 feet.

The Board of County Commissioners of Carbon County, Wyoming, have decided to locate a road to be known as the Sinclair - Platte River Road,

Beginning at a point on the east R/W line of the Sinclair - Seminoe Dam Road which is N. 50° 37' E. 3411.3 ft. from the S.W. corner of Sec. 16, T. 21 N., R. 86 W. of the 6th Principal Meridian, thence N. 59° 23' E. 2700 ft., thence N. 89° 13' E. 298.9 ft. to the East line of Sec. 16, thence N. 89° 13' E. 4459.7 ft., thence N. 58° 05' E. 987.6 ft. to a point on the East line of Sec. 15, T. 21 N., R. 86 W. which is 1034 ft. south of the N.E. corner of Sec. 15, thence N. 58° 05' E. 1823 ft., thence N. 58° 12' E. 445.9 ft. to a point on the north line of Sec. 14, T. 21 N., R. 86 W., which is 667.3 ft.
