BROWN'S HILL ROAD: A motion was made by Commissioner Salisbury, seconded by Cheesbrough and carried whereby the County Clerk was instructed to publish a notice of location of public road in compliance with Article 3, Chapter 48 WCS 1945 as amended.

NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyoming have decided to locate a road to be known as Relocated Section of Brown's Hill Road, Carbon County, Wyoming.

Commencing at a point on the east boundary of Section 8, T. 14 N., R. 89 W. which point is northerly a distance of 122 feet from the east quarter corner thereof; thence running in a southwesterly direction for a distance of approximately 3.1 miles through Sections 8, 17, 18 and 19, T. 14 N., R. 89 W. to a point of ending on the west line of said Section 19, a distance of 894 feet, more or less, northerly from the west quarter corner of said Section 19.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any land owner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said county before noon on the 6th day of April, A. D. 1955, or such road will be established without reference to such objections or claims for damages.
