SPRING CREEK ROAD RESOLUTION AND SAVERY-NORTH ROAD RESOLUTION.

A motion was made by Commissioner Cheesbrough, seconded by Salisbury and carried whereby the following resolutions were adopted.

#### RESOLUTIONS

WHEREAS, The Board of County Commissioners of the County of CARBON, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of county roads, the location and extent of which is as follows:

#### SPRING CREEK ROAD: SC-CFM 4284 - State Project

From a point on Wyo. 130. 2 miles south of Saratoga, southwesterly for a distance of approximately 7 miles.

Grading, Draining, Surfacing, 1½" oiled mat and miscellaneous work.

#### SAVERY-NORTH ROAD: SC-CFM 4285 - State Project

From a point approximately 2½ miles northeast of Savery in Sec. 33, T. 13 N., R. 89 W., thence northeasterly for a distance of approximately 5 miles.

Grading, Draining, Surfacing and miscellaneous work.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
