COMMISSIONERS' PROCEEDINGS

TAX LEVY MEETING

The Board of County Commissioners met August 6, 1956, at 10:00 a.m., all members present, together with County Assessor, R. A. Hakala, for the purpose of fixing the Tax Levies for and within Carbon County for the year 1956-57 in compliance with Chapter 32-512, Wyoming Statutes of 1945.

Having received from the State Board of Equalization notice that the assessed valuation of Carbon County for the year 1956-57 has been found to be \$41,391,607.00, The County Assessor advised the Board of the assessed valuation of each of the various municipalities and school districts within the County, and the Board proceeded to fix the levies upon the assessed property of Carbon County for the year 1956-57, as follows:

COMMISSIONERS PROCEEDINGS
REGULAR MEETING

The Board of County Commissioners met at 10:00 a.m., all members present. The minutes of meetings held July 3, 5, 23 and 24th, 1956 were read and the Resolution adopted on July 5, 1956 relative to the establishment of Spring Creek Road - Project No. SC-SFM 4284 - 1956 amended as follows:

"Commencing at a point in Section 24, T. 17 N., R. 84 W. of the 6th P.M., Wyoming located N. 39° 09' E. a distance of 312.35 feet from a point on the south boundary of said Section 24, from which the south quarter corner thereof bears S. 88° 42' E. a distance of 482.3 feet;
thence running in a southwesterly direction for a distance of approximately 7.8 miles through Sections 24, 25, 26 and 35 of T. 17 N., R. 84 W., Sections 3, 10, 9, 16, 17, 20, 29 and 30 of T. 16 N., R. 84 W., to a point in Section 30 of said T. 16 N., R. 84 W., which point is S. 31° 40' W. a distance of 287.3 feet from a point on the east boundary of said Section 30, from which the northeast corner thereof bears northerly a distance of 636.0 feet."
